President's Report:

President, Tom Halstead, reported the Chesterfield United Soccer Club was inquiring about possible membership in SEVYSA for the fall 2005 season. It was clarified that, should this occur, this club would be scheduled like any other club. President Halstead reported that the last scheduled VYSA meeting had been cancelled due to weather and that there was no VYSA report at this time.

Secretary's Report: the board approved the minutes from the December 2004 meeting with the Athletic Club Norfolk representative listed as excused.

Administrator: Denise Edwards confirmed with each club the number of VYSA workshop attendees and the number of hotel rooms required.

Registrar: President Halstead advised the board that Dawn Krause had been dismissed by the league as the registrar for the Chesapeake Select Soccer Club due to failure to exercise her responsibilities. President Halstead offered Chesapeake Select an opportunity to nominate a replacement registrar to support the club along with Churchland Soccer League and Tidewater Soccer Club. Churchland was advised to consider a nomination should Chesapeake not have a volunteer.

Unfinished Business: Chris Friant was elected as the new competition chair and he indicated that the spring meeting would be held on Sunday, 27 February 2005 with time and location to follow.

New Business: The Churchland Soccer League inquired about a waiver for its U-11 team to possibly be placed in a U-12 division for the spring with some actual U-10 players on the team. The board gave its approval to this possibility. It was clarified that all approved waivers from the fall were requested for the entire year with the possible exception of a waiver for the Smithfield U-10 team. Smithfield was asked to revisit the status of this team and to request any required waiver by email prior to the scheduled competition committee meeting.
