- Treasurer's report: Income from spring registration to date: \$9,100.00; expenditures total \$1,091.57.
- VYSA: Proposed by-law amendment as of 9/1/04: If a player, for disciplinary reasons, is restricted from playing in local club/organization, this will be enforced at the state level as well.
- Competition: Proposed divisions will be e-mailed to club reps only instead of being posted on the SEVYSA site.
- Administrator: Youth Leagues program allows the administrator to mass e-mail to all listed in the club registration. Please check e-mail addresses for accuracy.
- Spring divisions: CSSC Dynamo should have been in proposed U10B.
ERSC Rage should be in U13B, was listed as U13B and U14B in proposed divisions.

Divisions were approved except for the corrections as proposed.
