VYSA has been able to negotiate a reduced rate for background checks; hence no fee will be charged for the 2003-2004 seasonal year.

**League Registrar:** No report.

**Administrator's Report:** Denise Edwards distributed the schedule packets for the Fall 2003 season to the clubs. Denise reported that all teams playing in the IL divisions received seven (7) match cards. The two extra match cards are to be used to report scores for the matches played in Richmond. Divisions having eleven (11) teams were scheduled with one (1) team having a bye each week and with an extra double header. RMYSL did not enter either U17 or U18 teams in these IL divisions.
